3. FIXATION OF RATE FOR ISSUING A COPY OF ELECTORAL ROLLS (VOTER LIST).

To consider and fix rate for issuing a copy of electoral rolls for the ensuing Ordinary Election of Cantonment Board, Barrackpore. As per Cantonment Electoral Rules, 2007, "any person whose name is borne on the electoral roll as finally published in a ward shall be entitled to purchase from the Chief Executive Officer, at a reasonable price, to be fixed by the Board or where a Board has not been constituted, the Officer Commanding the Station, one copy of the roll of his own ward". In the last Cantonment Board Ordinary Election held on 11.01.2015, the Board vide CBR.No.2 dated 15.11.2014 had fixed the rate for issuing of Electoral Rolls @ Rs.250 per copy per ward.
