- A. <u>Business regulations of the Civil Area Committee and its power and duties under section 48(1)(e) of the Cantonments Act, 2006.</u>
- i) Clause 52 may be read as under:

The Minutes of the Civil Area Committee shall be recorded in a separate book kept for the purpose and placed before the Board at its next meeting for consideration and approval. Until approved by Board, decision of Civil Area Committee will be recommendatory in nature. Provided that the minutes of the Civil Area Committee shall, in so far as such minutes relate to matters mentioned in sub-section (3) of section 47 of the Cantonments Act, 2006 and clause 43(i) e) of this Business Regulations of Civil Area Committee shall be construed as decision of the Cantonment Board.

Smt. Sikta Das, Member opined that as she is not a member of the current Finance Committee, so she has no say in its proceedings. But in the current disposition, as a member of the Board she could give her suggestion/objection on any points passed by the Finance Committee.

Smt. Arpita Bhattacharya is also of the same views of Smt. Sikta Das. If an elected member is not part of Finance Committee, then any developmental work in their ward might be ignored in the Budgetary process and their ward may suffer.

Shri Kalyan Choudhary, Chairman of the present Finance Committee opined that there are so many demands of the Ward Members. He felt that before passing the Budget, consent of all elected members is very essential. So, the opinions of all elected members are necessary for passing of the Budget.

Shri Madhusudan Shaw, Member & Smt. Tulilekha Ganguly, Member opined that the proposed amendments in the Business Regulations of Finance Committee is not required and the minutes of the Finance Committee should be recommendatory in nature.

Shri K. N. Saha, VP & Shri Shib Sankar Adhikari, Member opined that the proposed amendments are contradictory to the Cantonments Act, 2006 and the proposed amendments in the agenda side seems to be not democratic, since all elected members would not be part of the Finance Committee. So, they are not in agreement over this proposal.

Above mentioned proposed amendments in Clause 57(a), 57(d) & 65 wrt draft Business Regulations of Finance Committee are not accepted, since Finance Committee would consist of only 3 elected members and there would be no say of remaining 4 elected members in the matters of Finance Committee. The minutes of the Finance Committee should be recommendatory in nature as passed in the Draft Business Regulations vide CBR No.3 dated 05.06.2020 and as amended vide CBR No.4 dated 28.12.2020.

C. Business regulations of the Health & Environment Committee, and its power and duties under section 48(1)(e) of the Cantonments Act. 2006.

Shri K. N. Saha, VP and all other elected members opined that all the elected members are not the member of Health & Environment Committee, hence there would be no say of remaining other elected members in matters pertaining to Health & Environment Committee.
