2. Any person who claims to be entered in the Electoral Rolls and who is not entered therein or is entered in an incorrect place or with incorrect particulars may put in a claim addressed to the Chief Executive Officer to have his/her name entered, or the registry corrected, as the case may be.
3. Any person whose name is borne on the Electoral Rolls and who objects to the inclusion of his/her own name, or that of any other person whose name is on the roll, may prefer the objection addressed to the Chief Executive Officer.
4. Claims shall be preferred in Form III and objections in Form IV or Form IV-A appended to this notice and must be signed by the claimant or objector or by his/her duly authorized agent; copies of the forms will be supplied free by the Chief Executive Officer.
5. Claims and objections may be presented to the Chief Executive Officer at any time during office hours or sent by post but it must reach him within twenty days of the date of issue of this notice.
6. Claims and objections which are not preferred in the proper form or are not received by the date prescribed will be rejected.
7. All claims and objections received in time and in proper form will be heard by The President, Cantonment Board, Barrackpore or his nominee [some other person not being an elected member, the Chief Executive Officer or a Servant of the Board, as per Rule 16(1) of the Cantonment Electoral Rules (CER), 2007] at the Office of the Cantonment Board, Barrackpore.
