**ORDER REGARDING ELIMINATION OF SINGLE USE PLASTIC (SUP)**

1. Pursuant to direction received from the DG DE, MOD, Govt. of India in reference to Government of India subsequently notified PWM (Amendment) Rules, 2021 on 12.08.2021 vide which:-  
  
*"The manufacture, import, stocking, distribution, sale and use of following, "Single Use Plastic" including polystyrene and expanded polystyrene, commodities shall be prohibited with effect from the 01<sup>st</sup> day of July, 2022:-*
  - a. ear buds with plastics sticks, plastic stick for balloons, plastic flags, candy sticks, ice-cream stick, polystyrene (Thermocol) for decoration;
  - b. plates, cups, glasses, cutlery such as forks, spoons, knives, straw, trays, wrapping or packing films around sweet boxes, invitation cards and cigarette packets, plastic or PVC banners less than 100 micron, stirrers.
2. Also, refer Sub Section (5) of Section 289 of the Cantonment Act, 2006, The Cantonment Board, Barrackpore shall ensure prevention of storage, supply, transport, sale, distribution and use of above said plastic items and whoever in Cantonment Board, Barrackpore manufactures, supplies, carries or uses for packaging or any other purposes material of non-biodegradable nature including polythene bags shall be punished with fine which may extend to five thousand rupees or imprisonment which may extend to six month.
