Expression of Interest (EoI)

Interested private limited companies, public, limited companies, or proprietorship firms presently operating in India with valid GST, PAN Card, and Udyog Aadhar Card and possessing a minimum of 03 years of experience collaborating with at least 03 Cantonment Boards / Municipal Corporations / Development Authorities/ SUDA / NULM or other government entities for the development and provision of essential facilities in the street vendor market, including the development of designated street vending zones under Street Vending Rules and regulations of the livelihood security and Street Vending Act 2014, may request a comprehensive proposal from the Cantonment Board, Barrackpore until 25th November, 2024, 1700 hrs.

The deadline for the preparation and submission of proposals is 25th November, 2024. Following the receipt of proposals within the stipulated period, the Cantonment Board will conduct an examination analysis, and presentation of the proposals, culminating in a final decision. Details of terms and condition pertaining to this project can be download from the official website of Cantonment Board, Barrackpore i.e. https://barrackpore.cantt.gov.in/ from 05.11.2024.

The proposal outlines the implementation of a Smart street vendor Market for vendors under the pilot project. It includes the establishment of the vending zone at Barrackpore Cantonment at the sites mentioned above incorporating features such as MIS (Management Information System) software for bazar monitoring, Bio-metric survey, Data Entry Operation, smart ID card generation and printing and integration with SQL server as well as Bio-Metric Machine , vendor certificate printing , market layouts for efficient vendor placement , Additionally essential market facilities such as proper lighting, toilets, waste management, and provisions for solar and fire safety are emphasized.

The proposal aims to provide fundamental amenities in the market, such as appropriate lighting infrastructure, sanitation facilities, waste management systems, Proper entry exit facilities, vehicle parking, and smart street vendor carts with solar and fire safety measures, along with features like glowing signboards and pay loon.

Interested entities are expected to submit their bids in compliance with the specified rules and conditions for consideration.

Terms and Conditions:

- 1. The officials of Cantonment Board, Barrackpore will first inspect the technical envelope and examine the documents related to the experience of the project. Only those envelopes will be opened whose technical experience is found to be appropriate for this work.
- 2. The examination system of documents by the officials of Cantonment Board, Barrackpore will assign a technical score of 80% for technical documents and 20% for financial documents.
- 3. Before allocating the work, Cantonment board, Barrackpore may demand a practical demonstration in a board meeting from all companies participating in this tender.

 Separate technical and financial envelopes will be maintained. The technical envelope will be labeled as such, and the financial envelope will be labeled accordingly. The technical envelope will contain only

technical documents, and the financial envelope will contain financial documents.

Eligibility Criteria for Bidding Company:

- 1. The bidding company should be a Private Limited Company/Public Limited Company/Proprietorship Firm and should have been operating in India for the past 5 years. The company should possess GST, PAN card, Industry Aadhar card.
- 2. The Private Limited Company/Public Limited Company/Proprietorship Firm should have undertaken at least **three projects** related to establishment of street vendor market in collaboration with Cantonment Board or Municipal Corporation, HUDA, SUDA, NULM, or any other government authority, along with developing Bazar monitoring MIS software for this purpose. The company with greater experience shall be given priority over other competing companies
- 3. The Private Limited Company/Public Limited Company/Proprietorship Firm should have experience in preparing plans and maps for at least three projects related to urban development under the rehabilitation project for path vendors over the last 5 years.
- 4. The company or firm should have conducted a biometric-based survey of 15,000-16,000 path vendors in the same city and prepared 35-40 maps based on the online management information system (MIS software) data entry and report generation.
- 5. The company or firm should have undertaken the work order or MOU for establishing a street vendor market in at least three different Cantonment Boards or Municipal Corporations that provide comprehensive services free of cost.
- 6. For this project, it is mandatory to have a work order for establishing three path vendor markets and applying for the MOU. Submitting documentation for a survey experience of at least 25000 path vendors is essential.
- 7. The bidder will be required to present their previous work at the Cantonment Board office. The Board will make its decision based on the presentation provided by the bidder regarding their experience. An idea for civil works is essential for setting up a market.
- 8. The date for the bidder to provide the presentation can be obtained from the Board office after the submission of the bid.

Note: The bidder will not receive payment from the Cantonment Board, Barrackpore for all the services mentioned in the bid. This project is to be completed in its entirety in "PPPP" mode.

For the first month of establishing the market, the company will carry out tasks such as free cleaning, monthly rent collection, operation of CCTV cameras, deployment of security guards, and maintenance of electricity and water facilities, etc. The Cantonment Board, Barrackpore will determine the right of the bidder to collect the specified amount from path vendors per month.

All companies participating in this tender must mandatorily demonstrate their previous work during the board meeting through a laptop. Additionally, a technical description of the cart used for market establishment must be presented in the form of a new cart constructed for a demo in front of the board members. The Board members will only allocate the work after thoroughly inspecting the quality of the cart and verifying the success of the company in similar projects.
