E-tender had been invited by the Board vide Tender Id: 2025_DGDE_719153_1 dated 08.07.2025, for the provisions of processing of Municipal Solid Waste as per Solid Waste Management Rules 2016, as Amended in 2020 and other applicable rules thereof for Solid Waste Management Processing Facility at Trenching Ground of Cantonment Board Barrackpore for a period of 03 (three) years from the date of communication of acceptance of the tender through Defence eProcurement Portal (<https://defproc.gov.in/nicgep/app>). For wide publicity, notice was also published in the Bartaman (Bengali daily), Sanmarg (Hindi daily) and the Times of India (English daily).

For the above, total 07 (seven) nos. of firms submitted the bid in due date and time.

In accordance with the procurement guidelines, a thorough evaluation process was carried out by the Technical Bid Evaluation Committee (TEC), to ensure fairness, transparency and compliance.

During scrutiny, Technical Evaluation Committee (TEC) found that, out of 07 (seven) nos. of participating bidders, wherein 04 (four) nos. of participating bidders were disqualified due to non-submission of requisite documents as per ATC.

Hence, Technical Evaluation Committee (TEC) recommended to evaluate the bids of only 03 (three) nos. of Technically Qualified Bidders.

For the above, total 03 (three) nos. of firms submitted the bid in due date and time.

In accordance with the procurement guidelines, a thorough evaluation process was carried out by the Technical Bid Evaluation Committee (TEC), to ensure fairness, transparency and compliance.

During scrutiny, Technical Evaluation Committee (TEC) found that, out of 03 (three) nos. of participating bidders, wherein 02 (two) nos. of participating bidders were disqualified due to non-submission of requisite documents as per ATC.

Hence, Technical Evaluation Committee (TEC) found that only 01(one) firm namely *Gayatre Enterprise*, had submitted all the requisite documents as mentioned in the Technical Bid.

Since, only one (01) firm (i.e. *Gayatre Enterprise*) is eligible for opening of their Financial Bid as per requisite documents uploaded by the firm, the Technical Bid Evaluation Committee (TEC), recommended to cancel the ibid tender and call for fresh e-tender, for providing the ibid service, in order to ensure more competition among the bidders and to obtain a competitive rate for providing the ibid service.


