To consider the matter in connection with the proposal to disburse the ad-hoc bonus to all eligible Cantonment Board employees for the F.Y 2024-25 as per direction issued by Dte EC vide letter No.363067/LC-3/III/135 dated 16.10.2025, that Non Productivity linked Bonus (Ad-hoc bonus) is only for the accounting year 2024-25 and no arrears of previous year's bonus will be paid, till receipt of sanction / direction from MoD/DGDE.

All employees of the Cantonment Board Barrackpore have been earnestly requesting the release of the ad-hoc bonus which remains long pending for previous years, namely FY 2019–20, 2020–21, 2021–22, 2022–23, 2023–24 and 2024-25 — making it a total of six consecutive years.

In view of the prolonged delay in disbursement of bonus while continued dedicated service of the staff, it has been humbly requested by all staff that the adhoc bonus for at least the current financial year 2024–25 be released. This will go a long way in addressing the genuine expectations of the employees and boosting their morale.

It is further submitted that appropriate Budget Provision for the same has already been made in the current year's Revised Budget Estimates. The approximate expenditure towards the payment of ad-hoc bonus for F.Y 2024-25 is estimated to be Rs. 7.60 Lakhs.

The Barrackpore Cantonment Board proposes to introduce a modern Small Digital Theatre on Class 'C' Defence Land measuring approximately 5000 sq. ft. at Survey No. 165/1, with the objective of generating sustainable revenue for the Cantonment Board and providing a state-of-the-art means for public entertainment and educational facility within the Cantonment area.

This innovative entertainment and educational facility is envisioned to provide immersive 360° projections for astronomy shows, scientific documentaries, cultural programs, civic awareness content and commercial movies for entertainment etc. thereby enriching the cultural and educational environment of the Cantonment.

The initiative is designed to enhance the quality of life of residents, troops, families, and visitors, while promoting community learning, environmental awareness, and public participation.

The project shall be executed under the PPPP Model, wherein:

- The Private Partner will undertake the design, installation, operation, maintenance, and management of the facility.
- The Cantonment Board will not incur any expenditure, as all costs related to establishment, operation, staffing, and maintenance will be borne by the private partner.
- The Board's role will be primarily regulatory and supervisory, ensuring transparency, public benefit, and compliance with Ministry of Defence policies.
- The People's participation element will ensure that the local community benefits from affordable ticket access, educational content, and public awareness programs and lots more.

Salient Features of the Proposed Project

- 1. Name of Project: Small Digital Theatre.
- 2. Location: Sy. No. 165/1, Class 'C' Land, Barrackpore Cantonment (Approx. 5000 sq. ft.)
- 3. Concept: Small digital theatre featuring 360° projections for science education, astronomy shows, and cultural screenings along with commercial movies etc.
- 4. Capacity: Seating for 40-60 persons per show (subject to final design approval).
- 5. Facilities Proposed:
 - o Small theatre with digital projection and sound system.
 - Waiting lounge and ticketing counter.
 - Solar-powered energy backup.
 - Restroom and drinking water facilities.
 - o Digital signage and CCTV surveillance.
 - Accessibility for persons with disabilities.

- o Educational and cultural programs for schools, residents, and troops.

- Annual lease rent and revenue share payable to Cantonment Board as per RFP conditions.

 - o Noise-controlled and energy-efficient systems.

The total area earmarked for the project is approx. 5000 sqft. As per STR and existing policy guidelines, the rental value can be fixed @ 2.5% of the value of Defence Land, as per Para 5B(a) of the MoD Policy Letter dated 02.02.2016, read with subsequent amendments dated 21.10.2020 and 03.03.2022. This comes to approx. Rs.3,42.035/- which may be fixed as the MRP of the project.
